She successfully completed the National Institute of Trial Advocacy's Advanced Trial Practice course after having tried a number of cases.

Ms. Zwerling has extensive experience in all phases of securities litigation, including trials and appellate arguments. She has been and is lead counsel or a member of an executive committee in many complex cases, including: *McCoy, et al. v. Cullum & Burks Securities, Inc., et al.*, C.D. Cal., Civ. No. 8:09-CV-01084-DOC (RNBx); *Vonage Initial Public Offering (IPO) Securities Litigation*, Civ. No. 07-177 (FLW) (D.N.J.); and, *In re: Old Banc One Shareholders Securities Litigation*, N.D. Ill., Civ. No. 00C2100. *McCoy* involves a series of alleged private offerings of notes by brokers across the country which were to be secured by health care receivables, but went into default.

She currently represents mutual fund investors in high-profile cases claiming that funds were charged excessive fees for investment advisory services in violation of Section 36(b) of the Investment Company Act of 1940. These cases include: *In re BlackRock Mutual Funds Advisory Fee Litigation*, No. 14-115 (D.N.J.); *Kennis v. Metropolitan West Asset Management, LLC*, No. 2:15-cv-8162 (C.D. Cal.); *In re Davis New York Venture Fund Fee Litigation*, No. 1:14-cv-4318 (S.D.N.Y.); and *Zoidis v. T. Rowe Price Associates, Inc.* (D. Md.).

Ms. Zwerling is an active member of the Second Circuit Federal Bar Council. She had been co-chair of the Membership Committee and now is a member of the Program Committee. As a member of that committee, Ms. Zwerling plans and coordinates Continuing Legal Education programs.
